



Scholarship Grant Program AGREEMENT FORM

Deadline: January 5, 2020

Austin Junior Volleyball wants to provide an opportunity for all girls to be able to achieve their full athletic potential as a volleyball player while promoting leadership, teamwork, friendship, character, goal setting and self-discipline.

Your signature indicates your understanding of the following:

- Scholarship grants will only be issued to those players who have applied **NO LATER THAN January 5, 2020** and have demonstrated financial need.
- Scholarship grant money is distributed based on the funds available and the number of qualified families who have applied **NO LATER THAN January 5, 2020**.
 - **THEREFORE, THERE IS NO GUARANTEE THAT YOUR PLAYER WILL RECEIVE FINANCIAL ASSISTANCE.**
 - **FURTHERMORE, FAMILIES SHOULD NEVER EXPECT TO RECEIVE MORE THAN 10% OF THE ANNUAL DUES IN THE FORM OF A SCHOLARSHIP GRANT.**
- If your family requires additional assistance, be prepared to actively participate in the work program.
- Because scholarship grant funds are limited, we ask that an application only be submitted if your current family circumstances would make playing for Austin Junior Volleyball a financial hardship.
- Please note that there are alternate payment plans available. Please contact Amanda Chapa in the accounting department for more information (512-433-5108; achapa@austinsportscenter.com).
- **Any player that has one or more past due payments on his or her account will not be eligible to receive a scholarship grant until such time as the account is brought current.** If the account is not current by the time at which the Scholarship Committee meets to determine awards, the player will forfeit the opportunity to receive a scholarship grant that season.
- If your family still owes a balance from a prior season you **WILL NOT** be allowed to apply for a scholarship grant until that balance is paid in full; if the scholarship grant deadline is missed because a previous year's balance has not been paid or **addressed** with the accounting department, **your family will forfeit the opportunity to receive scholarship grant money that season.** However, money can still be earned through participation in the work program.
- **SCHOLARSHIP GRANT FUNDS HAVE NO MONETARY VALUE.**
 - Should the scholarship grant funds disbursed to your player's account result in a credit balance, the total of the credit balance will be returned to the scholarship fund to be redistributed to other players in need.
 - If your player has applied for a Scholarship grant and his or her account has been paid in full at the time the Scholarship Committee meets in March, he or she will not be eligible to receive a grant because there is no outstanding balance to which a grant can be applied and Scholarship grant funds have no monetary value.
 - **PLEASE NOTE THAT IT IS YOUR RESPONSIBILITY TO CONTACT THE ACCOUNTING DEPARTMENT PRIOR TO THE MONTH OF MARCH IF YOU NEED YOUR PLAYER'S FINAL INVOICE DUE DATE EXTENDED TO THE MONTH OF APRIL SO THAT A BALANCE EXISTS TO WHICH A GRANT CAN BE APPLIED.**
- Any scholarship grant funds disbursed to your player's account will be applied to the last invoice on your account first and will continue to be applied to the farthest outstanding balance until the amount of funds awarded is exhausted.
 - **YOU ARE STILL RESPONSIBLE FOR PAYING THE MONTHLY DUES ON YOUR ACCOUNT IN FULL BY THE DUE DATE DESIGNATED EACH MONTH.**

We understand the extent of the financial responsibility involved in Club volleyball. That being said, we are always willing to work with your family to the best of our ability insomuch as it does not create a disadvantage for other players. If your financial situation changes during the season, we ask that you keep our accounting department updated so that we can work with your family's budget and circumstances. Thank you for your attention to this matter and we wish everyone a successful volleyball season!
